so as to read as follows:

9.2 A resolution for the adoption of a proposed
amendment may be provided either by the board of
directors or by the members of the Association.
Directors and members not present in person or by proxy
at the meeting considering an amendment may exercise
their approval in writing, provided such approval is
delivered to the Secretary at or prior to the meeting.
Such approvals must be by not less than two-thirds of
the entire membership of the board of directors and by
a majority of the units represented at a meeting at
which a quorum is present. Unit owners may vote by
proxy.

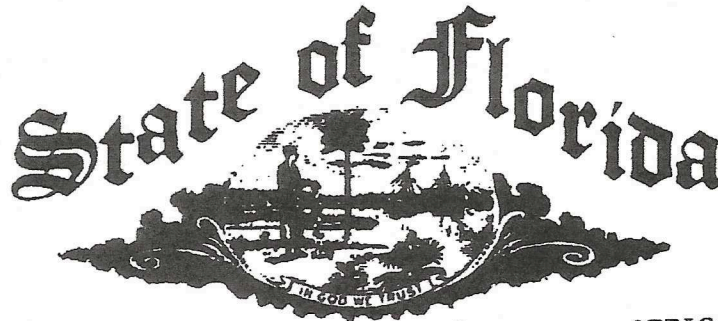
