(C) Neither a unit owner nor the Association shall make
any alteration in the portions of a unit or condominium building
that is to be maintained by the Association, or remove any portion
of such, or make any addition to them, or do anything that would
jeopardize the safety or soundness of a condominium building, or
impair any easement, without first obtaining approval in writing
of owners of all units in which such work is to be done and the
approval of the board of directors of the Association. A copy of
plans of all such work prepared by an architect licensed to
practice in this state may be required by the Directors prior to
the start of the work.

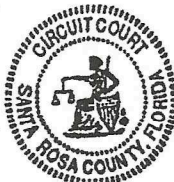
